NISSAN SPIN AND WIN COMPETITION 2019

Terms and conditions

Eligibility & entry:

- 2. How to enter:

- 6. To enter this Promotion, the entrant must visit the URL provided by the Promotor in the Invitation and answer the following question correctly: *"What is the name of Nissan's electric passenger car?"* ("Qualifying Question"). Entrants who have answered the Qualifying Question correctly will have the chance to participate in spin and win.

Winner selection and notification:

- 8. Once the entrant has spun the wheel, the entrant will be notified instantly if they have a won a Prize ("Winner") or are unsuccessful.
